PALM BEACH SOCCER CLUB FUNDRAISING RAFFLE 2024 TERMS AND CONDITIONS

- 1. Information on how to enter the raffle forms part of the terms and conditions of entry.
- 2. Complete entries will include a name an email address and/or a telephone number, at a minimum.
- 3. Entrants are not restricted or limited to the number of raffle tickets which may be purchased.
- 4. Raffle ticket sales will conclude at the discretion of PBSC.
- 5. Entrants need not be present to win.
- 6. The prize cannot be transferred or redeemed for cash.
- The draw for the winner will take place between 12pm and 8pm on the day of 31st August 2024 at The Palm Beach Soccer Club, 81 Nineteenth Ave, Palm Beach QLD 4221.
- 8. The Palm Beach Soccer Club (PBSC) reserves the right to request the winner to submit their ticket stub as proof of identity and purchase. Proof of identification and entry considered suitable for verification is at the sole discretion of PBSC.
- 9. If for any reason the raffle is not capable of running as planned, including (but not limited to) tampering or any other causes beyond the control of PBSC, which corrupt or affect the administration security, fairness or integrity or proper conduct of the raffle, PBSC reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, take any action that may be available including cancelling, terminating, modifying or suspending the raffle, pursuant to any direction given under the Charitable and non-profit Gaming Act 1999 (QLD).
- 10. In the case of the intervention of any outside agent or event which naturally changes the result or prevents or hinders its determination, including but not limited to vandalism, power failures, tempests, natural disasters, acts of God, civil unrest, strikes; the PBSC may in its absolute discretion cancel the raffle being drawn and draw at another time on the same conditions subject to Queensland legislation.
- 11. A person is not eligible to enter a category 2 or 3 art union if the person is—
 - (a) a member of the management committee of the eligible association conducting the art union; or
 - (b) directly engaged in conducting the draw of the art union; or
 - (c) the eligible association conducting the art union; or
 - (d) a member of the immediate family of a person mentioned in paragraph (a) or (b).
- 12. The winner will be notified by phone or email within 4 days of the winners being drawn, and the winner's details will be published on the PBSC website and Facebook page within 7 days of the winners being drawn unless the winner specifically requests for their details to not be published.
- 13. The Prize is valued at the recommended retail value as provided by the supplier and is correct at time of printing. The prize value is in Australian dollars.
- 14. PBSC shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to direct or consequential loss) or sustained in connection with the prize, except for any liability which cannot be excluded by law.
- 15. PBSC will take no responsibility for the prize being damaged in transit after the prize has been claimed and collected
- 16. The prize will be delivered by PBSC or a third party within 1 month after the winner has been decided unless;
 - (a) The winner agrees in writing that the prize may be delivered more than 1 month after the winners are decided; or
 - (b) After making all reasonable efforts, the person conducting the game can not locate the prize winner

- 19. The period for claiming a prize is 3 years after the day the prize winner is decided
- 20. If PBSC is unable to locate a prize winner, or can not deliver a prize, for the game, The prize must be kept for at least 1 year from the day the prize winner is decided
- 21. If the prize is not claimed within 1 year, PBSC may apply the prize or its sale proceeds to the association's purposes. However, this does not affect a person's right to claim a prize during the period mentioned in section 19
- 22. PBSC accepts no responsibility for any kind of loss or liability suffered or incurred by any of the prize-winners in relation to the prizes or the promotion. The winner releases PBSC, it's volunteers and employees, from all liabilities, loss and damage of any kind arising at any time out of or in connection with the acceptance of, and participation in, the prize or the promotion.
